The Government of India has launched a new Scheme namely Promotion of Agricultural Mechanization for IN-SITU Management of Crop Residue in the States of Punjab, Haryana, Uttar Pradesh and NCT of Delhi.

The following senior officers will address the Agriculture Development Officers, Revenue Officials (not less than Kananugo/Patwari) and officials/field functionaries of the Department of Environment/Pollution Control Board and sensitize them about the importance of prevention of stubble burning and importance provisions under the new scheme namely:

1. Establish Farm Machinery Banks or Custom Hiring Centres on In-Situ Crop Residue Management Machinery
2. Financial Assistance for procurement of Agricultural Machinery and equipment for In-Situ Crop Residue Management Machinery
3. Information, Education and Communication for awareness on In-Situ Crop Residue Management including advertisement and publicity, awareness camps, mobilization of school/college student etc.
5. Farmers awareness camps at village and block level


